#### **Position summary**

Lead all rehabilitation and construction activities related to the Choice Neighborhoods
Implementation Grant and the recapitalization of THA's public housing portfolio. Manage activities in compliance with HUD policies and procedures and coordinate all planning, design, and construction activities from review and finalization to eventual redevelopment or rehabilitation of existing properties.

#### **Summary of Duties:**

- Work with THA Developer partner on multi-phased, mixeduse, apartment community, ensuring decisions are made in the best interest of the housing authority;
- Create project management timelines including scope, budget, and schedule for all recapitalization and construction projects.
- Manage, monitor, and track all aspects of projects from predevelopment through commitment, loan closing and construction
- Manage multiple rehabilitation and construction projects simultaneously.

- Work in conjunction with other THA divisions to ensure a coordinated approach to the "Choice Neighborhoods Implementation Grant (CNI)" process that is compliant with all HUD rules and regulations.
- Work with THA teams to create property-level strategic plans that integrate physical characteristics, capital needs, analysis of best uses, and property operations in a single approach to maximize property performance.
- Work with members of THA departments, developers, the City and other officials to create a property-level financing plan for each recapitalization project.
- Attend development related meetings as the primary subject matter expert on all issues related to design, rehabilitation, and construction.
- Manage procurement of recapitalization related services in conjunction with THA's Construction Department.
- Develop and implement a system to coordinate and monitor progress of all "Choice Neighborhoods Implementation Grant (CNI)" related consultants and contractors.
- Develop and implement Quality Assurance (QA) process for "CNI" related rehab/construction and transition this QA process to oversight of ongoing property maintenance.
- Complete and submit all HUD required documents related to planning, design, or construction of existing properties.
- Other duties as assigned.

#### Minimum requirements

Bachelor's degree in architecture, construction management, engineering or a related field and five (5) years of experience managing the construction/rehabilitation of large capital projects. Master's degree is preferred. Other Desired Certifications Include: Registered Architect, LEED Accredited Professional. Must have valid driver's license.
